Fund for Gender Equality

As Canadian communities work towards a just recovery, the Fund will support ambitious, local projects that advance gender equality. The Fund will shift power into the hands of women, girls, Two-Spirit and gender-diverse individuals by supporting their leadership and engagement in community-level initiatives.

In 2020 and 2022, the Fund will be hosted by participating community foundations who will make a total of \$3.4M available to projects in their communities. A list of participating community foundations is [here](#).

The Application Process



As a first step, please review the [Applicant Guide](#) for important information about the Fund and eligibility criteria. Participating community foundations will receive applications to the Fund for Gender Equality from **October 3 and October 31, 2022**.

Once you have confirmed that your community foundation is participating and that your project is eligible, review the application questions below. All applications to the Fund for Gender Equality will be received through the online platform at <https://cfc-fcc.smapply.io/>. Hard copies or email attachments will not be accepted.

Here are a few useful tips:

- Click the “register” button in the top right corner to create an account
- Begin completing answering the questions in each section
- You’ll be able to save your answers as you go

Task 0: Eligibility Quiz

If your organization meets the eligibility criteria below, you are encouraged to apply for the Fund for Gender Equality, a collaboration between CFC and the Equality Fund with support from the Government of Canada.

Note: the Eligibility Quiz and Application must be completed by a representative of the organization (qualified donee, see Question A) who will accept and be responsible for this grant.

The Fund for Gender Equality will support projects led by **qualified donees**, or organizations partnered with qualified donees, that are at the **‘heart’** of the women’s movement— those



organizations that have demonstrated a long-term commitment to empowering women, girls, Two-Spirit, and gender-diverse people through their mission, activities, and/or partnerships.

Organizations would be considered at the “heart” of the women’s movement if they have demonstrated a long-term commitment to empowering women, girls, Two-Spirit, and gender-diverse people through their mission, activities, and/or partnerships.
