TERRITORIAL ACKNOWLEDGEMENT

The Foundation of Greater Montréal (FGM) would like to highlight the presence of the Kanien'kehá:ka of the Kahnawà:ke and Kanehsatà:ke communities, which have historically been established on the lands now known as Greater Montreal. We would also like to acknowledge that this land has been home to many other Indigenous Nations over several historical periods. A diverse Indigenous population, including First Nations, Métis, and Inuit, continues to live here today, in a range of socioeconomic conditions.

This land has long served as a site of meeting and exchange for many First Peoples, and it is here that the Great Peace of Montreal was signed by 39 First Nations in 1701. In the spirit of peace, justice, and reconciliation, and in drawing inspiration from the ancestral knowledge of Indigenous Peoples, FGM is working to enhance the well-being of the communities in Greater Montreal, and to protect this territory, for now and for future generations.

JUSTICE, EQUITY, DIVERSITY AND INCLUSION

The values of justice, equity, diversity, and inclusion are at the heart of our mission at the Foundation of Greater Montréal, which aspires to reflect the community it serves. A word from the Chair of our Board of Directors and our President and CEO

At the Foundation of Greater Montréal (FGM), we've kicked off our 25th anniversary celebrations. This milestone is an opportunity to reflect on all we've achieved, but also to look ahead and anticipate how we'll rise to the challenges of the next 25 years.

FGM aspires to build a community free from poverty and discrimination, where everyone can fulfill their potential in a healthy environment—today and into the future. This vision is our lifeblood. It drives us every day and encapsulates our commitment to all communities in Greater Montreal. Whatever the political and economic headwinds, we stay the course and reaffirm our values—justice, equity, diversity, inclusion, collaboration, listening, creation, innovation, and integrity.

The Foundation's philanthropic practices strive to be transformative. They are designed to equip communities to take action on the systemic factors behind issues including inequities, exclusion, and environmental degradation, and not just their consequences.

For this reason, the Foundation is seeking to increase our support for causes and populations that are too often neglected. FGM's **Collective Fund for Climate and Ecological Transition** is one good example. The latest iteration of this fund aims to support the resilience, empowerment, and transformational capacity of communities in the face of climate change, through an environmental justice approach focused on communities rather than technical solutions.

This year, FGM also hastened our shift towards trust-based philanthropy. Simply put, trust-based philanthropy means recognizing the expertise of organizations working on the ground. We have adjusted our calls for projects and reporting processes, and now offer more multi-year, unconditional funding in addition to other support measures. We believe that philanthropy should encourage innovation in recipient organizations and that by working together, we can come up with solutions that truly address our society's current and future challenges.

In 2024, the Foundation also added impact investing to our toolbox. Needs are rapidly growing, and simply granting funds is no longer enough. By pursuing both financial returns and significant social and environmental benefits for Greater Montreal, we aim to put all the financial resources entrusted to us to work.

Today's philanthropic capital needs to be more than just a means of generating returns: it must become a tool for change. What if you could invest in the well-being of your community the same way you would for shares or stocks? Impact investing makes that possible. FGM is pursuing new opportunities in this market, and we are now encouraging all our circles to join us.

The world around us is changing, but our determination remains the same. In 2025 and beyond, we will continue to push the boundaries of philanthropy to build a just society for today and tomorrow.

FGM SERVICES

THE FOUNDATION OF GREATER MONTRÉAL IS YOUR FOUNDATION

Donations to FGM are invested responsibly, generating returns that increase the value of your gift. We work to maximize the benefits of every dollar entrusted to us, taking into account local populations and communities, as well as wider social and environmental impacts. The Foundation of Greater Montréal is here to help bring your philanthropic project to life!

OUR SERVICES

Fund creation

Creating a philanthropic or endowment fund is like establishing your own private foundation—except that you don't have to worry about managing it. You choose the sectors or organizations you want to support and the FGM team will take care of the rest!

Donations to existing funds

Your donation to one of FGM's many existing funds, like one of our Collective Funds, will be pooled with those of other donors and invested to generate returns that will support causes that matter to you.

Planned giving

By planning to make a charitable gift upon your death, you can invest part of your estate in the well-being of future generations. This option allows you to extend your commitment to the community without impacting your current financial situation.

ADVANTAGES OF WORKING WITH FGM

With the Foundation of Greater Montréal's support, our fund creators can:

- structure their philanthropic endeavours and sustain their values of sharing and mutual support, while inspiring people close to them
- recommend organizations to benefit from their donation or allow our team to advise them
- create a fund anonymously, in their own name, in their family's name, or in tribute to another person, organization, or event

FGM also works with registered charities to:

- help them create their own philanthropic or endowment fund to finance their operations and mission
- manage an existing fund on their behalf, while providing access to a diversified, high-performance, and low-cost portfolio
- assist them in taking part in matching programs they are eligible for

SEVERAL FUND TYPES TO CHOOSE FROM

FGM offers great flexibility thanks to our range of fund types, allowing the returns on your donation to be distributed as efficiently as possible.

● Unrestricted fund

You entrust FGM with determining the issues your fund will support, ensuring that your donation will benefit the entire community as effectively as possible.

● Sectorial fund

If you're looking to support a cause that matters to you but are unfamiliar with the organizations working in that field, a sectorial fund is the right option for you. FGM's team will follow your instructions in selecting the beneficiaries who best match your priorities.

● Donor-advised fund

Each year, you advise FGM of which organizations you would like to see receive income from your fund. You can make these recommendations yourself, or name a family member or advisory committee to do so.

● Donor-designated fund

You specifically recommend charitable organizations to benefit from the income generated by your fund each year.

● Auto-designated fund


Non-profits and charities can also create their own auto-designated fund, establishing a new income stream they can then use to support their activities.

● FGM fund

You can also contribute to one of FGM's own funds to support our distribution programs.

The philanthropic and endowment funds offered by FGM can be held in perpetuity or for a fixed term (with a one-year minimum). You can also choose whether to distribute only the income generated by your fund, or part or all of the capital. It's up to you! The FGM team will help you find the option that best suits your philanthropic goals.

YEAR IN REVIEW



Throughout 2024, the Foundation of Greater Montréal team continued to expand our vision of impact philanthropy, leveraging the strength of our network and prioritizing the diverse needs of the community. Thank you to everyone who created or contributed to an FGM fund this year, as well as to all the organizations that partnered with or received support from the Foundation. Together, you make up a dedicated community driving real change and improving the well-being of Greater Montreal's residents. You embody the Foundation's vision of building a community free from poverty and discrimination, where everyone can fulfill their potential in a healthy environment—today and into the future.

DEVELOPMENT AND PROMOTION OF PHILANTHROPY

FGM uses a variety of means to democratize and promote philanthropy in the communities we serve. While these efforts are largely dedicated to our own growth, they also aim to foster a broader culture of philanthropy across Greater Montreal. In 2024, the Foundation spared no effort in encouraging the community to invest in their own well-being and future.

FGM'S AMBASSADORS NETWORK

Officially launched in 2023, the Foundation's Ambassadors Network hit the ground running this year, welcoming three new members and recommending around a dozen people to the philanthropic development team. The network's members met twice to discuss the best strategies for amplifying the visibility and reach of their funds and raising awareness about the Foundation's services. By sharing their philanthropic vision and fund creation experience with friends and family, their networks, and even the media, these individuals demonstrate what can be achieved with FGM's support.



Thank you, Mr. Comtois!



This year, the Foundation of Greater Montréal lost one of its most tireless builders and ambassadors, Pierre Comtois. Mr. Comtois and his wife, the late Micheline Comtois, created their fund with the Foundation in 2009 to support many causes and institutions important to them, including supporting the mission and operations of FGM itself. Mr. Comtois also sat on the Foundation's Board from 2008 to 2014 and was named an honorary member in 2015. More recently, he generously accepted an invitation to join FGM's Ambassadors Network, in which he was a driving force. We are especially grateful to him for his 15 years of trust, loyalty, and commitment to the Foundation.

DEMYSTIFYING THE MECHANICS OF PHILANTHROPY

Despite their generosity and good intentions, our donors can still face a challenging task in deciding what to give, as well as how, when, and to whom. Philanthropy—and the rules and institutions that surround it—can be complex. That's why the Foundation takes every opportunity we can to inform the public about our work and explain the mechanisms that make it possible for people to strategically give back.



In 2024, through FGM's Rendez-Vous, the Foundation's team held a [webinar](#) (in French) on how to create a philanthropic fund and plan charitable donations. Alongside three panelists, Linda Tchombé, Director, Philanthropic Development, shed new light on these issues and answered participants' questions.



Ms. Tchombé was also a guest on the [L'investisseur transformé podcast](#), hosted by Ruben Antoine, portfolio manager at Tulett, Matthews & Associates and [fund creator](#) at the Foundation. This platform enabled FGM to reach a new audience to promote our services and the benefits we offer donors.

FGM and our spokespeople were interviewed by or quoted in the media over 60 times this year. Both mainstream media and specialized publications turn to the Foundation or our published information to enhance their analyses and reports as they pertain to philanthropy and the many social and community issues in which FGM is involved.

SOME OUTSTANDING DONATIONS

The Foundation thanks everyone who created or contributed to a fund this year. Every philanthropic project, new fund, and donation matter. Here are two great examples of the commitment of FGM donors and how philanthropy can bring our values to life.

Philippe Bélanger

After a long and distinguished career with McCarthy Tétrault, Philippe Bélanger was appointed a judge of the Superior Court of Québec for the district of Montreal in 2020. He also cofounded the Welcome Collective, an organization whose mission is to support asylum seekers settling in Quebec. This year, he created the Fonds de la famille de Philippe Bélanger, which also aims to provide assistance to immigrants. Prematurely taken from us by illness, Mr. Bélanger ensured lasting support for the most vulnerable in our community.

May Kersten

In 2006, May Kersten created the May Kersten Social Justice Fund at FGM. This donor-designated fund provides annual support to several social justice organizations, including Equitas, Microcrédit Montréal, and Éduconnexion. Ms. Kersten has often contributed to her own fund over the years, in addition to planning a generous bequest. Following her passing, \$4 million was added to the May Kersten Social Justice Fund's capital, which will ensure the long-term impact of her philanthropic work. We thank her and will remember her for her extraordinary generosity.

Every philanthropic project, new fund, and donation matter. They show how philanthropy can bring our values to life.



PHILANTHROPY INCENTIVE PROGRAMS

In order to support the arts and promote cultural philanthropy in our community, FGM is a partner in matching programs that encourage philanthropy in these fields. Registered cultural organizations can create a fund at FGM and then submit grant applications for funds that will match the product of their fundraising efforts. The income generated by the investment of subsequent governmental or private contributions, coupled with the cultural groups' own endowments, serves to develop and maintain their activities for the benefit of creators, cultural workers, and the community as a whole.

MÉCÉNAT PLACEMENTS CULTURE PROGRAM

This program aims to ensure the independence and financial security of non-profit organizations in the fields of culture and communications. It fosters the creation of permanent funds and encourages these organizations' fundraising efforts by matching the funds raised.

As of December 31, 2024, this program was operating in **410 funds** at FGM, representing a total value of **\$165,559,129**. This year, **eight new funds** were created.

In 2024, the Government of Québec distributed **\$1,162,120** in matching grants to participating organizations' funds.

CANADIAN HERITAGE PROGRAM

Established in 2001 by Canadian Heritage, the Canada Cultural Investment Fund (endowment incentives component) encourages arts organizations to develop new revenue streams. The federal government provides a financial incentive which serves to supplement donations raised.

From the creation of this component in 2001 up to December 31, 2024, funds of participating organizations placed at FGM received **\$19,235,834 in grants** from Canadian Heritage, for a minimum amount of **\$38,471,670** to be held in perpetuity as part of the restricted assets of the

Foundation, for the benefit of the **49** non-profit professional arts organizations that are the recipients of the income generated by the investments.

This year, FGM managed **109 funds** in connection with the Canadian Heritage program, including **two new ones**. In 2024, the Government of Canada distributed **\$1,078,026 in matching grants** to funds of participating organizations placed at FGM.

MÉCÉNAT MUSICA PROGRAM

Mécénat Musica is a cultural program created in 2013 by donors, for donors. It encourages individuals to make an in-perpetuity donation of \$25,000 to a cultural organization close to their hearts and encourages donating families to give \$250,000 or \$2,500,000 to match these individual donations, helping create a major shift in the cultural philanthropy landscape. Since the very beginning, the Foundation has been involved in the program, which celebrated its 10th anniversary in 2023.

Donations from Mécénat Musica are all the more impactful because they add to the initial amount that a cultural organization entrusts to FGM before even applying for a matching grant from the Mécénat Placements Culture and Canadian Heritage programs.

As of December 31, 2024, a total of **44 organizations** working with FGM have received funding from the program.

In 2024 alone, **five organizations' funds** at FGM were funded by the program. Over the course of the year, **\$1,317,902** in total (excluding government matches) was deposited to the funds of participating organizations, creating restricted assets of **\$62,165,649** (including government matches) for the benefit of the **44 non-profit professional arts organizations** that receive the income produced by these investments.

FINANCE AND INVESTMENT

Philanthropic funds are not like other financial assets. At the Foundation of Greater Montréal, we believe that these funds should be invested in a way that reflects the values of the causes they support. We therefore take great care in investing the assets entrusted to us and seek to maximize their positive impact on the community.

This commitment led us to adopt our **Responsible Investment Strategy** in 2021. One of its key goals is to reduce our portfolio's greenhouse gas (GHG) emissions by 45% by 2030, in line with the objectives of the Paris Agreement. We surpassed this target in 2024, cutting our portfolio's emissions by 50% compared to 2021, from 79.9 to 39.8 tCO₂ per \$1 million invested.¹ FGM will publish a comprehensive responsible investment report in the fall of 2025.

OPTIMIZATION OF FGM'S INVESTMENT TOOLS

In 2024, FGM strengthened the operation of our Investment Fund (FGMIF) in order to better align our business practices with our mission, improve our financial performance, and offer better services to donors in Greater Montreal.

On June 30, iA Financial Group became the FGMIF's lead manager, while the Normandin Beaudry firm began providing investment advice to the Foundation's team

and members of our investment committee. By separating the management and advisory functions in our investment structure, FGM has strengthened the independence of our investments and improved both their transparency and efficiency.

As the FGMIF now has access to the iA Group's multi-management platform, we can draw on a wider range of financial products. This increased flexibility provides FGM with more resources to achieve our objectives, both in terms of returns and responsible investment.

Moreover, iA and Normandin Beaudry are both Québec-based companies with experienced teams well positioned to meet FGM's rigorous requirements. By partnering with these firms, the Foundation is now working with more managers and sub-managers in Montreal and Quebec, as stated in our **Investment Policy**.

In short, FGM is now fully benefitting from the creativity and innovation of Montreal's financial sector, a global hub for sustainable finance.

Creation of the Impact Investment Subcommittee

In November, the Foundation of Greater Montréal launched its Impact Investment Subcommittee (IISC). The mission of the IISC is to identify investment opportunities that will generate strong returns while delivering positive and significant social, environmental, and community benefits aligned with FGM's values. Thank you to the members of the new committee for sharing their expertise and enthusiasm!

PARTNERSHIPS WITH OTHER COMMUNITY FOUNDATIONS

This year, FGM signed new agreements with other community foundations in Quebec. Under the terms of these partnerships, these foundations will now invest a portion of their assets in the Foundation of Greater Montréal Investment Fund, benefitting from its competitive returns and the expertise of its investment committee, as well as economies of scale in management fees.

So far, FGM has formed such partnerships with community foundations in the Laurentians, Outaouais, and the Richelieu-Yamaska regions. These collaborations are a natural fit for us, as we share a common mission with our counterparts: to leverage philanthropic resources in our areas for the benefit of local communities.

The Foundation also co-organized the Climate Connections conference with the Waterloo Region Community Foundation, which boasted over 20 participating Canadian community foundations. The aim of the event was to strengthen community foundations' action on climate change. FGM President and CEO Karel Mayrand presented the many initiatives FGM has launched since making climate action a central focus of our strategic plan.

AN EXAMPLE OF IMPACT INVESTING: THE FONDS AMPLIFIER MONTRÉAL

After several years of preparatory work, the Fonds Amplifier Montréal finally became a reality in 2024. The Amplifier initiative is backed by a collective of philanthropic foundations in the metropolitan area, including the Foundation of Greater Montréal. Through this initiative and in collaboration with other public and private institutions, the collective aims to support the development of green, affordable housing in Greater Montreal. Together, the foundations will invest close to \$50 million in patient capital to fund the construction or renovation of housing units by local non-profit organizations and housing cooperatives.

In addition to generating a long-term financial return for investors, these residential projects will also help ease the housing crisis by providing affordable units, contributing to our region's socio-ecological transition, and reducing the real estate sector's climate footprint and GHG emissions.

The impact criteria include prioritizing neighbourhoods where the housing crisis is being felt most acutely, providing a minimum threshold of family-friendly housing (units with two or more bedrooms, for example), and buildings that are universally accessible, include communal spaces and amenities, rely on fossil-free power, and more. The first projects funded by the Fonds Amplifier Montréal are expected to launch in 2025.



¹ **Methodology:** Scope 1 and 2 carbon emissions (in metric tons of CO₂ [tCO₂] emitted per million dollars invested) for each strategy as determined by fund managers, weighted by each strategy's allocation in the FGM portfolio. Total carbon emissions (the sum of these values) are then normalized by the average coverage ratio of the portfolio. Missing data (12% as at December 31, 2024) were estimated based on historical data.

COMMUNITY ENGAGEMENT

The Foundation aims to support the well-being of Greater Montreal residents and foster new solutions to address the issues facing them by listening to communities and promoting partnerships and collaborations that bring philanthropy closer to the people it serves.

EVOLUTION OF FGM'S GRANTMAKING PRACTICES

This year, FGM ranked 11th on the list of Canada's **Top 50 Equitable Funders**, published by Future of Good and QuakeLab. We are touched by this recognition of our efforts to transform philanthropy, particularly in matters of justice, equity, diversity, and inclusion. This work is an ever-evolving process, and we fully intend to continue refining our grantmaking practices and strengthening our high-trust relationships with the communities we serve.



The Foundation promotes the necessary transformation of the philanthropic sector, both internally and with our partners, largely through the principles of **trust-based philanthropy** and participatory grantmaking. In the spirit of knowledge sharing, and to encourage the adoption of best practices across the sector, FGM makes a point of sharing our experience in these areas.

In 2024, the Foundation's director of strategic initiatives and community partnerships, Marie-Andrée Farmer, took part in two initiatives: **The Philanthropic Year**, a journal published by the Canadian Philanthropy Partnership Research Network (PhiLab) and the **Social Transformation** project, run by a collective of woman leaders in Montreal's non-profit sector. Both platforms gave Ms. Farmer the chance to present FGM's goals, resources we have deployed, and obstacles we have encountered along the way.

Commitment to historically marginalized communities

In our **Strategic Plan 2022-2026**, the Foundation of Greater Montréal committed to allocating at least 50% of the amounts it pays out of its own funds to organizations run by individuals from historically marginalized groups or organizations that serve these communities. In 2024, 72% of our individual grants met this criterion, accounting for 83% of the total amount paid out by these funds.

The Foundation has also compiled and published a **Learning Report** on the implementation of the principles of trust-based philanthropy and participatory grantmaking, a case study of the most recent edition of its Collective Fund for Social Equity. FGM also held a **webinar** (available in French only) and a lunch-and-learn to explore these issues with experts from other foundations and the community.

But it is primarily in practice, rather than theory, that FGM applies these principles concretely through our own funds. To learn more about any of the Collective Funds described below, please refer to the **Foundation's website**.



Collective Fund for Social Equity


The mission of FGM's Collective Fund for Social Equity is to take action on social inequality issues in order to advance the causes of justice, equity, diversity, and inclusion. This fund prioritizes supporting groups that work with historically marginalized people, including Black, Indigenous, and racialized communities; 2SLGBTQ+ people; neurodivergent individuals; people with intellectual or physical disabilities; and women and girls.

Since 2024, this Collective Fund has backed organizations and initiatives that support asylum seekers, refugees, and migrants without status or whose status is temporary or precarious. Scheduled to continue until 2026, the Fund provides multi-year, unrestricted financial support to these groups, as well as a capacity-building program.

In highlighting these issues, FGM's consultation efforts in developing this edition of the Fund have helped channel support from other community stakeholders and funders for this chronically

underfunded sector that responds to pressing and immediate needs.

Since its creation in 2021, the Fund has granted nearly \$2.5 million to more than 60 recipients. By the end of the current funding cycle in 2026, this amount will exceed \$5 million.

The Women's Impact Montréal (WIM) Collective Fund

The Women's Impact Montréal (WIM) Collective Fund is a giving circle with the main mission of supporting organizations dedicated to the advancement and well-being of women and girls in our community. All members of the WIM Fund are involved in selecting which organizations benefit from its support.

Created in 2021 on the initiative of a group of women volunteers, the WIM Fund has granted a total of \$750,000 to 18 organizations across Greater Montreal working in a variety of areas including mental health, combatting violence against women, supporting women's access to employment and entrepreneurship, and defending the rights of women and girls.



Collective Fund for Climate and Ecological Transition

The Collective Fund for Climate and Ecological Transition aims to step up Greater Montreal's fight against climate change, enhance our adaptation and resilience, and support our ecological transition. With a focus on environmental

and social justice, the Fund supports organizations and initiatives empowering communities disproportionately vulnerable to the effects of the climate crisis—especially those living in built environments and neighbourhoods with unfavourable characteristics.

Since its launch in 2021, the Fund has distributed over \$1.2 million to 50 organizations and initiatives working towards these goals. Through this Fund, FGM recognizes the crucial work of grassroots, community-based and citizen-led organizations, movements, and networks—both emerging and small—that face various barriers to funding. This is but one example of how we are adapting our methods to the real, concrete needs expressed by the communities we serve.

Indigenous Initiatives Support Fund

Through unrestricted grants, the Indigenous Initiatives Support Fund assists organizations and projects addressing needs identified and expressed by Indigenous communities living in the area now known as Greater Montreal, both in urban areas and in the communities of Kahnawà:ke and Kanehsatà:ke.

The creation of this Fund reflects the Foundation's sincere desire to engage in a process of reconciliation with Indigenous communities and to acknowledge the particular issues they face as well as their own power to take action on them. Designed to foster reciprocal relationships between

Indigenous and non-Indigenous people, the Fund's operations reflect these goals and recognize the intricate and interdependent relationships between individuals, community, and territory.

Since 2021, FGM's Indigenous Initiatives Support Fund has provided nearly \$500,000 to almost 30 recipients working on a variety of issues including teaching and preserving Indigenous languages, cultures, and knowledge; youth engagement in their communities; and access to culturally appropriate health care.

STRENGTHENING OUR RELATIONSHIPS WITH INDIGENOUS COMMUNITIES

Adopted in the fall of 2023, our [Roadmap towards Reconciliation](#) is intended to guide the ongoing development of the Foundation of Greater Montréal's actions in decolonizing its organizational and philanthropic practices, and in building reciprocal and lasting relationships with the Indigenous nations and communities that have traditionally inhabited and continue to live in communities served by FGM. In 2024, FGM paid in-person visits to communities to gather knowledge, educate ourselves, and build on the spirit of the Roadmap.

TRIPS TO THE MCCORD STEWART MUSEUM AND THE KAHNAWÀ:KE COMMUNITY

[Indigenous Voices of Today: Knowledge, Trauma, Resilience](#), a permanent exhibition at the McCord Stewart Museum in Montreal, bears witness to the still unrecognized knowledge of Indigenous peoples in Quebec and Canada, as well as the deep wounds they carry and their incredible resilience. Last summer, members of our staff, board of directors, and committees

had the privilege of attending this exhibition, where we read and heard powerful and inspiring testimonials from many members of the eleven First Nations who live in Quebec. Driven by hopes of engaging in a dialogue that would enable a better mutual understanding, the exhibition offers a genuine encounter. We encourage the entire Greater Montreal community to go see it.

In the fall, FGM's Community Engagement Committee went to Kahnawà:ke to strengthen ties with our partners and learn more about ongoing initiatives in the community. We visited four organizations that we've been collaborating with for a few years: [Kahnawà:ke Collective Impact](#), [Connecting Horizons](#), Kanien'kehà:ka Onkwawén:na Raotíóhkwa Language and Cultural Center ([KORLCC](#)), and [lonkwaká:raton](#) (Sharing Our Stories), a project founded and supported by [The Eastern Door](#).



COMMUNICATIONS AND MAJOR PROJECTS


Another key aspect of the Foundation of Greater Montréal's mission is to support partnerships and initiatives that disseminate knowledge and robust data about the current state of our community and about philanthropy as a tool for community development. In 2024, this pillar took many distinct forms.

VITAL SIGNS OF GREATER MONTREAL

Through our **Vital Signs of Greater Montreal** series of reports, FGM aims to inform and bring together the members of our community, encouraging them to take action on the most important issues we face. By collecting and disseminating reliable, contextualized data on the state of our community, we aim to stimulate and support reflection, collaboration, and the development of solutions that address these issues.

VITAL SIGNS ON TERRITORIAL INEQUALITIES

Through our work marshaling philanthropy to support the well-being of the most marginalized populations in Greater Montreal, FGM has an inside view of the impacts of territorial inequities on quality of life. With the publication of the latest **Vital Signs** report this fall, our goal was to provide a global look at this issue and enable our community to better understand and improve the fundamental relationship between people's lives and their environment. Thanks to the work of Vivre en Ville's experts, the report documents inequalities in housing, mobility, access to shops and services, public health, and climate resilience throughout Greater Montreal.

INDICATEURS VITAUX DU GRAND MONTRÉAL

This year, the Foundation also teamed up with the Communauté métropolitaine de Montréal and twenty or so other partners to launch the **Indicateurs vitaux du Grand Montréal**. This open platform, available only in French, displays strategic data on the development of complete and sustainable communities in Greater Montreal. This new tool will help improve our understanding of the territory we all share, the challenges we collectively face, and the solutions we must implement to address them. A dynamic map allows users to view the data according to different geographic parameters.



VITAL SIGNS ON PHILANTHROPY IN BLACK COMMUNITIES

In 2024, the Foundation also kicked off the work that will ultimately culminate in the next Vital Signs report, which will focus on philanthropy in Black communities in Quebec. Conducted in partnership with the **Observatory of Black Communities in Quebec**, a specialized research group affiliated with the **Afro Youth Summit**, this research project aims to take stock of philanthropy in Black communities in our province and highlight their unique philanthropic realities through both quantitative and qualitative data. Through these efforts, FGM wishes to recognize and highlight the contributions of communities in Greater Montreal that are all too often overlooked. This Vital Signs report will be published in 2025.

MONTREAL CLIMATE SUMMIT

Established in 2020 on the initiative of FGM and the Trottier Family Foundation with support from the City of Montréal, the **Montreal Climate Partnership** (MCP) is an independent entity dedicated to encouraging the community to work towards achieving its climate objectives. Since 2022, the MCP has held a yearly Montreal Climate Summit.

With over 900 participants, the **2024 edition** of the Summit demonstrated that the Montreal community is, once again, motivated to speed up the city's ecological transition and to enhance our resilience to climate change. More than 80 large employers signed a sustainable mobility pact and published a call to support public transit in Quebec.

Several international leaders and specialists shared their expertise at this summit. In addition, progress on commitments made in previous years was reviewed, and fifteen new major announcements were made. The fourth edition of the Montreal Climate Summit will be held in May 2025.



MAKING THE FOUNDATION CARBON NEUTRAL

Since 2022, FGM has committed to purchasing carbon credits annually to offset our greenhouse gas emissions as an organization, as well as those of our employees in the course of their professional duties.

We first estimated our emissions using a tool produced by **COOP Carbone**, a reputable organization in the field. The Foundation then purchased Gold Standard-certified credits from **Planetair**'s Africa Portfolio, to offset our 2024 emissions estimated at 27.1 tons of CO₂ equivalent, a similar carbon footprint to previous years.



A NEW LOOK ...


In anticipation of our 25th anniversary in 2025, the Foundation's team wanted to make a big splash on the visibility front. We believe that to fulfill our role as a community foundation, democratize philanthropy, and serve our diverse causes and communities, as many people as possible must know about FGM and our work. That's why we teamed up with **Republik**, a creative agency we chose for their commitment to creating social capital, culminating in our You Donate, We Make Money campaign.

Launched in early 2025, this campaign increases the Foundation's visibility in public space, but above all, it explains the uniqueness and advantages of FGM's philanthropic model. Through a striking slogan, the campaign spells out how a donation to FGM generates a financial return that increases over the long term, with greater benefits for society, the environment, and communities. In other words, donating to the Foundation of Greater Montréal means your money has multiple impacts.

... AND A NEW OFFICE!

Just in time to celebrate our first quarter century, FGM has moved into a new, brighter location that's more open and more conducive to collaboration. Our office is now located on the 10th floor of 606 Cathcart Street, directly across from Phillips Square.

This iconic downtown Montreal landmark, built in 1922, was the first office building in Canada constructed entirely from reinforced concrete, and once housed the first commercial radio station in the country. Our next chapter will be written in a setting with a rich history!



GOVERNANCE, TEAM AND FINANCIAL INFORMATION



The Foundation of Greater Montréal is governed by a diverse Board of Directors committed to the Greater Montreal community. Its members come from the business world, the public sector, and the non-profit sphere.

BOARD OF DIRECTORS

To fulfill its mandate, the Board is supported by five standing committees made up of both Board members and external experts. Committee reports are available on [FGM's website](#).

REPORT OF THE BOARD OF DIRECTORS

Over the past year, the Board of Directors held eight meetings, which focused on several items in pursuit of the objectives defined in the Foundation's 2022-2026 Strategic Plan. Most notably, the Board:

- participated in planning FGM's 25th anniversary
- approved the committees' annual work plans, as well as the budgets and statements of FGM and the FGM Investment Fund (FGMIF)
- recruited three new Board members
- recruited two external members to serve on the Audit Committee
- appointed FGM officers and committee chairs
- created the Impact Investment Subcommittee, approved its mandate, and appointed its members
- supported FGM's senior management in relocating FGM's offices
- mandated FGM's senior management to develop an impact investment fund project with the Impact Investment Subcommittee
- adopted a 0.65% increase in the FGMIF's management fees
- adopted a distribution rate of 4.25% for 2025

- accepted a donation of approximately \$3 million through a charitable remainder trust
- supported the signing of the Canadian Philanthropy Commitment on Climate Change
- adopted amendments to FGM's administrative by-laws
- adopted FGM's Politique sur la protection des renseignements personnels des employé·e·s de la FGM (Employee privacy policy).
- permanently adopted the signing procedure for the Politique de délégation de pouvoirs (Delegation of authority policy).
- adopted the proposed amendments to the FGMIF's Investment Policy

Three members left the Board in 2024, at the end of their respective terms. My warmest thanks to Kathy Fazel, Eric Lapierre, and Angelina Mehta for their dedicated efforts in advancing the Foundation's development over the past few years.

I would also like to thank all current Board and committee members, our President and CEO, and all FGM staff and members. Your contributions are vital; without you, the Foundation could not fulfill our mission of serving the communities of Greater Montreal.






TOTAL ASSETS UNDER MANAGEMENT, IN MILLIONS OF DOLLARS*, OVER FIVE YEARS


